Since 1981, the population has been increasing at a rapid rate. Between 1951 and 1961, the population increased rapidly. It is called the period of population explosion. The decadal growth rate during 1981-91 was recorded 23.87 percent as against 24.66 percent during the previous decades. (1971-81). Currently, despite overtaking China, India's population growth is slowing. The total fertility rate is below the replacement level of 2.1 for the first time according to the national family health survey. The current population of India is 1,454,180,397 as of Tuesday, October 1, 2024 based on world meter's elaboration of the latest United Nation's data. India population is equivalent to 17.78 percent of the total world population."

OUTLOOK OF INDIAN CONSTITUTION


